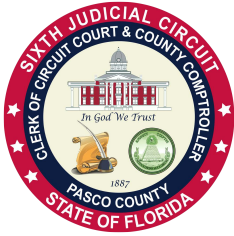
1. The Tax Deed number

Once the Tax Deed Department of the Clerk & Comptroller's Office receives the request, the current outstanding tax amounts will be requested from the Property Appraiser and the Tax Collector. When this information is returned to our office, the inquiring party will be notified, by mail, of the current purchase price.

Please Note: *The Tax Deed Department cannot request any outstanding tax amounts until a property has been on the List of Lands for more than 90 days from the date of original Tax Deed sale.*

After the requestor receives notification of the purchase price, the property may be purchased by:

- Contacting the Tax Deed Department of the Office of the Clerk & Comptroller of Pasco County at (352) 521-4408 or (800) 368-2411 ext. 4408 to coordinate the transaction
- The transaction must be **completed in person at our office** located at the East Pasco Government Center, 14236 6th Street, Suite 201, Dade City, FL 33523-3414
- Payment **must** be in the form of cash or certified cashier's check drawn from a Florida bank payable to Nikki Alvarez-Sowles, Esq., Pasco County Clerk & Comptroller
