TO ALL PEOPLE WHO WANT TO LIFT NO CONTACT ORDER:

If the charge is ***Domestic Battery***, you **MUST** complete the two hour victim's course given by the Salvation Army before filing the motion. Please call **727-247-9635** and an Outreach Advocate will contact you back to schedule an appointment for this. Once completed, attach documentation that the course was completed to your Motion. The Court will not schedule a hearing without this documentation.

1. Fill out the **top** of the form entitled *Motion to Allow Contact*.
2. Contact the Judicial Assistant for Judge Riba and she will give you a hearing date and time to fill in the blanks in the *Notice of Hearing* on the **bottom** of the page. You must sign both the motion and the notice of hearing.
3. Deliver or mail a copy to Judge Riba's office. Judge Riba has a mailbox located on the 3rd floor of the courthouse between courtroom B and C. You may buzz the office or call (727)815-7174 or mail to: *Judge Joshua Riba, West Pasco Judicial Center, 7530 Little Road, New Port Richey, FL 34654*
4. If all of these steps are not followed, the Judge will not consider your request on the hearing date.
