**[PROPOSED ORDER] GRANTING DEFENDANTS' UNOPPOSED MOTION TO
DETERMINE CONFIDENTIALITY OF COURT RECORDS**


THIS CAUSE came before the Court upon Defendants' Unopposed Motion to Determine the Confidentiality of Court Records (the "Unopposed Motion"). Having reviewed and considered the Motion and the Court file, and being otherwise fully advised, it is hereby **ORDERED AND ADJUDGED** that:

1. The Unopposed Motion is **GRANTED**.
2. The Court determines that the Limited Liability Company Agreement of Strategic Venue Partners Participation, LLC (the "LLC Agreement") attached as Exhibit 2 to the Declaration of Justin Marron attached as Exhibit A in support of Defendants' Combined Motion to Compel Arbitration and Motion to Dismiss, filed on September 12, 2023 in this case is confidential for purposes of Florida Rule of General Practice and Judicial Administration 2.420.
3. The LLC Agreement is confidential because it constitutes Defendants' business documents and disclosure of the LLC Agreement would substantially injure

Defendants. *See* Fla. R. Gen. Prac. & Jud. Admin. 2.420(c)(9)(A)(vi).

4. The LLC Agreement shall be kept under seal and shall be exempt from public access.
5. The Court finds that the remedy of sealing the LLC Agreement is no broader than necessary to protect the interests set forth in Florida Rule of General Practice & Judicial Administration 2.420(c), and that no less-restrictive measures are available to protect the interests set forth in Florida Rule of General Practice & Judicial Administration 2.420(c).
6. The Clerk of Court is **ORDERED** to seal the Limited Liability Company Agreement of Strategic Venue Partners Participation, LLC attached as Exhibit 2 to the Declaration of Justin Marron attached as Exhibit A in support of Defendants' Combined Motion to Compel Arbitration and Motion to Dismiss, filed on September 12, 2023.
7. The Clerk of Court is directed to publish this Order in accordance with Florida Rule of General Practice & Judicial Administration 2.420(e)(4).
