ADJUDGED that the party's name is not made confidential by this Order. It is further


ADJUDGED that the progress docket or similar records generated to document activity in this case are not to be made confidential. It is further

ADJUDGED that the natural guardians or the attorney(s) for the natural guardians are the only individuals who are permitted to view the confidential Court records, absent further order of this Court. It is further

ADJUDGED that this Court finds the degree, duration, and manner of confidentiality ordered by the Court is no broader than necessary to protect the interests set forth in Rule 2.420(c)(9)(A)(vii) and of the Florida Rules of Judicial Administration and there are no less restrictive measures available to protect the interests set forth in Rule 2.420(c)(9)(A)(vii) of the Florida Rules of Judicial Administration. It is further

ADJUDGED that the Clerk of the Court is directed to publish the order in accordance with Rule 2.420(e)(4) of the Florida Rules of Judicial Administration.
