AMENDED ORDER

THIS CAUSE coming before the Court this day, on the Plaintiff's Motion to Seal, and the Court having reviewed the Motion and the Court file finds the following:

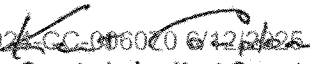
- A. Plaintiff has requested certain documents between the parties located in the file should be determined to be confidential in order to avoid substantial injury to themselves or to their families. The Court agrees that the relief is appropriate and proper.
- B. Rule 2.420(c)(9), Fla.R.Jud.Admin., states that court records shall be confidential when the Court determines that confidentiality is required to avoid substantial injury to innocent third parties and/or to avoid substantial injury to a party.
- C. The Court finds that the entry of a confidentiality order is necessary to protect from dissemination the parties arrangement, and to protect from public disclosure confidential and sensitive information.
- D. The particular records that are deemed confidential are identified as follows:
 1. Loan consolidation agreement filed March 27, 2025.
 2. Loan consolidation agreement filed March 21, 2025.
 3. Evidence documents filed March 12, 2025.
 4. Notice and motion filed March 10, 2025.
 5. Motion to seal filed March 8, 2025.
 6. Motion for Court's Default filed February 23, 2025.
 7. Motion(s) to reconsider emergency motion filed November 15, 2024.
 8. Emergency motion for temporary financial restraining order filed October 28, 2024.
 9. Order sealing proceedings filed October 26, 2024.
 10. Emergency motion for a temporary financial restraining order filed October 26, 2024.
 11. Emergency Motion filed November 15, 2024.
 12. Affidavit as to costs filed February 23, 2025.
- E. The Court further finds that the degree, duration and manner of confidentiality is no broader than necessary, and there are no less restrictive measures available, to protect the interests set forth herein.

It is therefore **ORDERED AND ADJUDGED**,

1. Plaintiff's motion is hereby **GRANTED**.

- a. The Clerk of Court is directed to keep the confidential documents referenced at paragraph D of this order confidential and under seal. If a motion or other document includes information from either of the confidential documents in the body of a motion or as an attachment, the confidential information may be redacted or otherwise sealed.
- b. No party's name is determined to be confidential by this order, and this order is not to be construed to require sealing of the Court or Clerk of Court's progress docket.
- c. No person is permitted to view the confidential materials specifically identified in paragraph D of this order.
- d. Pursuant to Rule 2.420(e)(4)(H), FLA.R.Jud.Admin., the Clerk of Court is directed to publish this order in accordance with Rule 2.420(e)(5), FLA.R.Jud.Admin.
